We, the signing parties, consider this document to be legally binding. all parties must accept any changes or additions to this contract. Alter Agreement (in order for the 2-year health guarantee to be valid, the alter agreement must be fulfilled.)  
This Maine Coon Kitten is sold as an (inside only) pet/show alter. Declawing of kitten/cat is not allowed and will void all health guarantees. As part of the purchase agreement, the buyer promises to have the kitten altered no later than 6 months of age (female), 8-10 months of age (male).

Upon the breeder's receipt of the veterinarian's verification of altering, the breeder shall provide to the kitten owner a kitten registration application to register the kitten with (TICA), The InternationalCat Association. **If the buyer fails to provide a spay/neuter statement for their kitten, the 2 year health guarantee is voided.** \*\*\*\*\* **If the seller does not receive verification of altering within ninety days after the date indicated above (Birth date + 6 months for females. Birth date + 10 months for males), an additional payment equal to the purchase price shall be immediately due and payable. The seller reserves the right to repossess the kitten in the event of failure or refusal of the buyer to comply with the terms of this agreement. \*\*\*\*\***

**KITTEN/CAT HEALTH GUARANTEE**

This kitten/cat is sold as an inside pet only. Allowing the kitten/cat to go outside, or declawing the kitten/cat voids all health guarantees.

**This kitten/cat is guaranteed to be FELV & FIV Negative on the date of sale.**

This kitten/cat is guaranteed to be free of any internal or external parasites on the date of sale.

This kitten/cat is guaranteed to be in good health at the date of sale. The guarantee covers any viral and/or bacterial diseases, or fungus infections. The guarantee **extends 7 days from the date of sale.**

**\*\*\*\*\* This kitten is guaranteed for two years from the date of sale not to have any genetic or birth defects that would negatively affect its health. This guarantee covers the purchase price only. \*\*\*\*\***

If during the guarantee period, the kitten appears ill, it is to be examined by a veterinarian. If the vet determines that the animal is ill and the illness was present prior to the sale, the breeder shall be contacted at once. The breeder shall (upon receipt of a statement from the examining vet. That the illness was present prior to the sale) pay the cost of medical treatment (up to, but not exceed, the purchase price of the kitten.)

If the kitten should die from a problem present prior to the sale, the breeder shall decide if a refund the purchase price is warranted.. The total liability of the breeder shall in no case exceed the total sale price of this contract.
